Pelo presente instrumento, de um lado **PIXEON MEDICAL SYSTEMS S.A COMÉRCIO E DESENVOLVIMENTO DE SOFTWARE** (CONTRATADA), inscrita no CNPJ/MF nº 05.662.773/0002-38, e de outro lado **HOSPITAL DO TRICENTENÁRIO - HOSPITAL JOÃO MURILO**, com endereço na Av. Henrique de Holanda, 87, Matriz, Vitória de Santo Antão - PE, CEP: 55602-000, inscrita no CNPJ/MF sob o nº 10.583.920/0004-86, (CONTRATANTE) tem entre si justo e acertado o presente Termo aditivo Contratual, que se regerá pelas cláusulas e condições seguintes:

CLÁUSULA PRIMEIRA – DO OBJETO: Constitui objeto do presente instrumento, a prorrogação da vigência do Contrato firmado entre as partes, cujo objeto é a aquisição e execução pela **CONTRATADA** de serviços relativos à solução Smart Health (MW-032022015R), por mais 12 (doze) meses, e reajustar o contrato com base no índice IGPM-FVG, no percentual de 5,7889%, que representa apenas 20% (vinte) por cento do índice publicado, exclusivamente para esta renovação.¹

CLÁUSULA SEGUNDA – DO PREÇO: O **CONTRATANTE** pagará a **CONTRATADA** o valor mensal de R\$ 8.463,77 (Oito mil quatrocentos e sessenta e três reais e setenta e sete centavos) mediante apresentação da Nota Fiscal/Fatura devidamente atestada pelo Setor Competente do **CONTRATANTE**, a partir de Março de 2021.

CLÁUSULA TERCEIRA – DA VIGÊNCIA: O presente Termo Aditivo terá seu termo inicial na data da sua assinatura, por mais 12 meses.

CLÁUSULA QUARTA – DA RATIFICAÇÃO: Ficam ratificadas as demais cláusulas e disposições do **CONTRATO** original, que não tenham sido expressas ou tacitamente revogadas, pelo presente termo aditivo.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, PIXEON MEDICAL SYSTEMS S.A. COMERCIO E DESENVOLVIMENTO DE SOFTWARE (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
